# **Disability Fraud**

Did you know that from it's inception through April 2016 the Cooperative Disability Investigations (CDI) Program efforts have resulted in \$3.4 billion in projected savings to SSA programs and \$2.3 billion in non-SSA programs nationwide? That is why it is very important to look for high risk fraud factors when adjudicating cases. Here is a brief list of factors that could point to potential fraud:

- Unreported work activity
- Allegation of illiteracy or no education
- Multiple family members receiving disability
- Frequent reapplications
- Mental impairments with no treatment or only very recent outpatient treatment
- Allegation of MR with no history of special education
- Poor cooperation on testing without good cause
- Pain allegation without documentation of pathology, no treating source or lack of response to treatment

The full list of high risk fraud factors can be found under adjudicator tools in the DDS Manuals. If you suspect possible fraud, be sure to refer your case to the fraud unit using the template e256! For more information, see Procedure 662.
