LAND USE POLICY CYCLE

LAND OWNERSHIP & CIVIC PARTICIPATION

Higher homeownership rates correlate with greater civic engagement in local governance (when homeownership is sustained).

DISPARATE IMPACT ON COMMUNITY HEALTH

Land ownership confers power to communities who use that power to influence the siting and distribution of health-promoting amenities or burdens.

FOOD JUSTICE: LABOR

THE NEW DEAL...

Under the National Labor Relations Act of 1935, American workers gained the right to organize and bargain collectively. Later, they established the 40hour work week, the minimum wage, and overtime protections.

...WAS NOT FOR ALL

Purposely excluded domestic and agricultural workers, as a race-neutral proxy for excluding black Americans from statutory benefits and protections made available to most white Americans.



FOOD JUSTICE: LABOR

FARMS

Immigration policy leaves many undocumented laborers vulnerable to abuse and wary of advocates. On VT farms, employers often double as landlords and as gatekeepers to services.

RESTAURANTS & STORES

Many food service workers exist in an industry that is permitted to pay them **unlivable wages**. Further, restauranteurs and grocers often make **trade-offs** between waste, aesthetics, quality, and supplier prices.



FOOD JUSTICE

Food Deserts Areas with few/no healthy food options.

Food Swamps

Areas with 4+ unhealthy food options for every healthy food T option

RACIAL EOUITY

CAUSAL RELATIONSHIP

Presence of food deserts & swamps tracks closely with prevalence of obesity, diabetes, heart disease.

FOOD INJUSTICE HURTS ALL SECTORS

- Poor nutrition \rightarrow negative health impacts
- Negative health impacts \rightarrow higher health costs & lower productivity.

COST OF DIAGNOSED DIABETES

Nationally, the cost of <u>diagnosed</u> diabetes has risen 26% over 5 years, totaling **\$327B** in 2017.

COSTS OF OBESITY

Obesity-related job absenteeism costs businesses **\$4.3B** annually & drives health care costs of over **\$200B per year**.
"OUTSIDERS" MAKING REAL CHANGE



Free breakfast is now one of the U.S. government's largest "welfare" programs. In 2012, it served breakfast to 12.9M children.

School breakfast had flown under the radar of both nutritionists and public policy theorists, until the Black Panther Party for Self-Defense made it a capstone program.

Access to nutrition enhances a student's psycho-social wellbeing, reduces aggression and school suspensions, and boosts test scores.

How decades of US welfare policies lifted up the white middle class and largely excluded Black Americans

When President Donald Trump met with the Congressional Black Caucus in 2018, the topic of welfare reform came up. One member of the caucus told Trump that enforcing stricter rules would be detrimental to her constituents, "Not all of whom are Black," according to NBC News.

WORKPLACE INJURY

Claimants are most often white males

BIAS IN COURT REPORTING

THE STANDARD

- Court reporters must achieve at least 95% accuracy in their transcriptions to be certified.
- They are tested on speed, punctuation, spelling, and specific medical and legal jargon in Standard American English (SAE).

THE REALITY

- For the study, 27 certified court reporters were asked to transcribe 83 sentences in everyday AAE.
- On average, the 27 court reporters achieved only 82.9% accuracy with AAE speakers.

THE CONSEQUENCE

- In 31% of the 2,241 transcriptions, the court reporters' errors changed the content of what the speaker was saying, misinterpreting either who was involved, what was happening, when it happened, and/or where it happened.
- "In some cases, the errors were not harmful, because they were uninterpretable. In others, they
 changed participants, actions, and order of events. [These errors] could make or break an alibi in
 the real world." –T. Jones, study author



BIAS IN COURT REPORTING

- "Once something is in the court record via the transcript, it legally becomes what was said even if it is inaccurate, which brings up questions of due process and equal protection under the law if some people are less likely to be accurately transcribed than others," –J. Kalbfield, study author
- None of the court reporters had training in AAE, despite it being widely common in their city and disproportionately represented in court.
- In 2017, Warren Demesme told Louisiana police, "Give me a lawyer, dawg." But police failed to end their interrogation and provide Demesme with a lawyer, as federal law mandates. Justice Scott Crichton justified their actions, writing that "the defendant's ambiguous and equivocal reference to a 'lawyer dog' does not constitute an invocation of counsel."

The proposed ordinance will quire them all to carry a labor identification card showing that they are regularly and usefully employed, and

the labor inspectors and police will be charged with the duty of rigidly

enforcing the law.

ISSUE-SPOTTING

- This was 1918... *after* Emancipation.
- Would this have happened if the men were here?
- Gatekeeping/envy in stay-at-home life.
- Right to work—*or not*, purpose of military pay, whose domestic needs supercede, "lazy" narrative.

Resilience & Empathy



RESILIENCE & EMPATHY GO HAND IN HAND

Resilience is *our* response. Empathy is *others*' response. ...but our resilience is partly based on whether others displayed empathy or behaved empathetically.

The fate of the harmed person may rest on whether a decision-maker feels empathy... and sometimes, you are that decision-maker.



COGNITIVE SHORTCOMINGS IN EMPATHY

Research shows White people are less likely to display empathy for the pain of non-White people than they are for White people.
∴ representation matters in decision-making roles.

This is not an excuse for you to take this as a given! Implicit bias is not "just the way things are."



CONSEQUENCES OF EMPATHY IN RESILIENCE

Focus on Diversity and Culture Cultural Differences in Response to Pain

A clients' culture influences their response to and beliefs about pain. Some common cultural differences related to pain are lated here.

Arabs/Muslims

- May not request pain medicine but instead thank Allah for pain if it is the result of a healing medical procedure.
- Pain is considered a test of faith. Therefore Muslim clients must endure pain as a sign of faith in return for forgiveness and mercy. However, Muslims must seek pain relief when necessary because needless pain and suffering are frowned upon.
 Arabs and Muslims prefer to be with family when in pain
- and may express pain more freely around family.

Asians

- Chinese clients may not ask for medication because they do not want to take the nurse away from a more important task.
- Clients from Asian cultures often value stoicism as a response to pain. A client who complains openly about pain is thought to have poor social skills.
- Filipino clients may not take pain medication because they view pain as being the will of God.
- Indians who follow Hindu practices believe that pain must be endured in preparation for a better life in the next cycle.

Blacks

Blacks often report higher pain intensity than other cultures.
 They believe suffering and pain are inevitable.

They believe in prayer and laying on of hands to heal pain and believe that relief is proportional to faith.

Jews

- Jews may be vocal and demanding of assistance.
- They believe that pain must be shared and validated by others.

Hispanics

- Hispanics may believe that pain is a form of punishment and that suffering must be endured if they are to enter heaven.
- They vary widely in their expression of pain: Some are stoic and some are expressive.
- Catholic Hispanics may turn to religious practices to help them endure the pain.

Native Americans

- Native Americans may prefer to receive medications that have been blessed by a tribal shaman They believe such a blessing allows the client to be more at peace with the creator and makes the medicine stronger.
- They tend to be less expressive both verbally and nonverbally.
- They usually tolerate a high level of pain without requesting pain medication.
- They may pick a sacred number when asked to rate pain on a numerical pain scale.

Joyce Echaquan: Racism played role in death, coroner finds

The death of an indigenous woman, Joyce Echaquan, last year was preventable and an "undeniable" case of racism, a Canadian coroner has said.

Ms Echaquan, a mother of seven, died shortly after recording a video of hospital staff insulting her.

Staff at the hospital in Joliette, Quebec had incorrectly assumed she was suffering from a narcotics withdrawal.

At a Tuesday press conference to explain the findings of her three-week inquiry, Ms Kamel said Ms Echaquan, who had a history of heart problems, was "infantilised" and labelled as a drug abuser by healthcare staff despite there being no evidence to support this.

This mistaken assumption affected Ms Echaquan's care, Ms Kamel said, and contributed to her death.

Asked if she thought Ms Echaquan would be alive today if she were white, Ms Kamel replied, "I think so" in French.

In a National Park Service survey, African-American respondents comprised just 7% of park visitors, and 16% of African American respondents said they hadn't visited a national park because they thought the parks were unsafe. Less than 5% of White American respondents responded this way.

- Everything has equity implications.
- Stop asking "Is s/he/that racist?" Ask instead "How much racism is being tacitly approved / tolerated here?"
- POC can perpetuate systemic racism too. Staff, contractors, and public officials of color are not immune from causing racially disparate harm.
