



North Carolina Disability Determination Services Social Security Administration Pilot Emailing With Claimants

In late September 2024, Hurricane Helene severely impacted the western Appalachian region of North Carolina, causing more than 100 reported deaths and significant destruction of communication infrastructure. Currently, federal policy only allows communication methods with people applying for disability benefits through phone calls, faxing and mailings via United States Postal Services. With over 6,000 disability claims from people impacted by Hurricane Helene and strained phone/postal service communications, the North Carolina Disability Determination Services (a division of DHHS) advocated to their federal partner, Social Security Administration, for a federal policy exception to contact people applying for disability benefits by email.

In December 2024, the North Carolina Disability Determination Services (NCDDS) received approval by Social Security Administration (SSA). NCDDS was asked to develop a 90-day pilot to support emailing people applying for disability benefits impacted by Hurricane Helene. NCDDS focused on developing a process that retained security of Personal Identifiable Information (PII) and decreased processing time with applications. On January 10, 2025 the NCDDS sent the first email. Since inception, 32 NCDDS processing teams have participated in the pilot. This pilot helps streamline communication to avoid untimely delays by sending emails to individuals about their claim.

The NCDDS pilot will continue through mid-April 2025 to focus continuous improvement to internal processes. At the time of this article, the NCDDS notes a timeframe of 38 days average processing time from the date the email was sent to the date the case was closed for people applying for disability benefits that respond to the NCDDS emails. NCDDS also observes a 33% response rate from emails to people applying for disability benefits. Given that this pilot is being conducted with no additional focus in obtaining email addresses and only with disability claims for people impacted by Hurricane Helene, this is exciting progress! 
